
## November 12, 2009 Japanese ODA Loan Signed with the Philippines Promoting National Logistics Infrastructure Development for Economic Growth

- 1. On November 9, JICA (President: Sadako Ogata) signed a Japanese ODA loan agreement in Manila, the capital of Republic of the Philippines, with the Development Bank of the Philippines (DBP) for up to 30.38 billion yen for the Logistics Infrastructure Development Project.
- 2. Through the DBP, the Logistics Infrastructure Development Project will provide two-step loans to local governments, the private sector and so on throughout the Philippines, financing medium- to long-term capital for logistics infrastructures. The JICA loan will be allocated to the financing of ship purchases and the construction of roads and logistics facilities such as for cargo and storage. A part of the loan will also be allocated to consulting services such as to improve the capacity of DBP to appraise subloans. It is expected to respond to local needs in a timely manner toward the construction of a logistics network having an optimized mix of inter- and intra-island transportation means.
- 3. Although the Philippines has achieved an economic growth rate averaging close to 5 percent over the past five years, the poverty level remains a high 30 percent, and achieving sustained growth to create employment is a critical issue. To that end, logistics infrastructures must be expanded to promote private investment from inside and outside the country. Compared to other ASEAN nations, not only does the Philippines still lack adequate infrastructures such as ports and roads, but infrastructures for processing, storing and transporting crops and livestock products are insufficient as well. With agriculture being the Philippine's key industry, the logistics infrastructure is a critical link for the quality of perishable goods and the costs of domestic distribution, and the inadequacy of the

With the aim of sustainable economic growth, JICA has a policy to provide a high level of assistance while integrating JICA's three tools of assistance—technical cooperation, ODA loans and grant aid—to assist the Philippine government in its focus on its limited social and economic infrastructures, which constrain growth.
- 6. In September and October 2009, typhoons Ketsana and Parma (known locally as Ondoy and Pepeng) caused tremendous damage in the Philippines. It is expected that this project will play a role in disaster recovery, and it is hoped that the project will be actively incorporated in the Philippines.
